SHERIFF WOULD LIKE FOR THE COUNCIL TO GRANT THIS REQUEST. SANDERS AND CARMONY SAID THEY THINK THEY NEED TO WAIT ON THIS AND SEEK LEGAL COUNCIL ON THIS, MOTION TO TABLE AT THIS TIME MADE BY SMITH SECOND BY CARMONY, APPROVAL TO TABLE 7-0
