MAJOR TILFORD PRESENTED TO THE COUNCIL THAT THE SHERIFF'S DEPT IS WANTING TO ORDER THEIR VEHICLES FOR 2014 NOW. IF THEY ORDER THE TAHOE'S NOW THEY WILL BE ABLE TO SAVE ABOUT \$3,000.00 PER VEHICLE. AND GET THEM SOONER. THE PLANT WILL BE SHUTTING THIS LINE DOWN SOON TO DO MAINTENANCE ON THE LINE AND THIS WILL PUT THINGS BEHIND. EMERGENCY MANAGEMENT:

MIKE SCHANTZ PRESENTED TO THE COUNCIL THE NEED FOR A NEW VEHICLE, THE CURRENT VEHICLE IS A 2004 WITH LOTS OF MILES AND INSTEAD OF FIXING PROBLEMS, IT WOULD BE CHEAPER TO BUY A NEW ONE. HE HAS PUT IT IN HIS 2014 BUDGET, BUT IT WOULD BE BETTER AND CHEAPER FOR HIM TO ORDER IT NOW AND TAKE POSSESSION OF IT THE FIRST OF THE YEAR, HE WILL NEED TO PLACE THE ORDER BEFORE THE END OF SEPTEMBER IN ORDER TO GET A 2013 MODEL AT 2011 PRICING.
