**EARLY LEARNING SHELBY COUNTY:**

Allison Coburn with Early Learning Shelby County came before the Council tonight to request \$1,000.00 to help with the expense of travel and conference fee for a conference on Saturday April 7, 2018. Allison advised this is a group of 15 professionals that help with this program that help with our 3.063 birth to 5-year-old children in Shelby County.

Claxton advised that he has been to two of their meetings and is highly supportive of this program. Allison advised she has also requested \$1,000.00 from the City of Shelbyville. Motion to approve \$1,000.00 pending advertisement was made by Claxton, seconded by Langkabel, approved 6-0

**COUNCIL:**
