Jacque gave a presentation on Tax Refund Exchange and Compliance System (TRECS) a program where Treasurers, Indiana Department of Revenue and Clearing House. Work together on collection of back taxes. Trying to keep people's property from going on Tax Sale.

Treasurer has list of people behind on taxes they are sent a letter and have 30 days to take care of the bill if not it is turned over to the Clearing House which in turn will work with the IDR. Then there is a 20.00 charge to the clearing house and 15% to IDR that comes off what is owed. There is not a charge to the county for this service. Currently there are six (6) Counties and one (1) city on this system. No action taken on the program
