RECORDER/ PERPETUATION ORDINANCE:

CORONER:

Brad Rund, Coroner, is requesting a salary ordinance amendment to be compensated on call employees. He requested \$50.00 for a 12-hour shift on call shift and \$100 for a 24 hour on call shift. Motion was approved to approve Ordinance 2023-41 was made by Sanders, seconded by Claxton, approved 6-0.

SHERIFF DEPT.

Louie Koch, Sheriff, is requesting to replace Jail Nurse. His current nurse is transferring to the Health Department to be the classroom instructor. Louie is requesting to obtain a service called QCC rather than hiring a new employee. This will save the County money. Motion was made to approve by Claxton, seconded by Langkabel, approved 6-0.

BROADBAND

Scott Rudd presented the Council with a presentation in regard to the County wide Broadband project. He spoke about getting investors involved. He explained the difference between RFI and RFP. Rough estimate of cost for the RFI and RFP would be around \$278,000.00 for both or \$80,000.00 for just the RFI. At this time Linda would like to take a look at next month's meeting to give the Council more time to review what was discussed. The Counsel advised the Council they could not act on the RFI or RFP because they did not have the information prior to the meeting in order to advertise as required by statute. The Council asked for this to be advertised for the January meeting. No action was taken. There being no further business a motion to adjourn was made by Claxton, seconded by Titus, approved 6-0.
