## MELISSA O'CONNOR/ YOUTH ASSISTANCE PROGRAM UPDATE:

Melissa O'Connor presented the Council with an Annual Update. Melissa advised since the program has started, they have had 970 referrals, currently they have 136 active and have had 159 new referrals. The program has had 90 Volunteers with six students tutoring.

They are in Partnership with Shelbyville High School, YMCA, for mentoring. They offer Scholarships for after school programs at the Boys & Girls Club, Food Basket Program for school breaks, Coats for Kids. O'Connor advised they have seen a decrease in Court Cases since the program started in 2016 the courts had 234 cases and in 2021, they only had seventy-seven cases. O'Connor advised one they really need now is more Volunteers. No action was needed.

### **HUMAN RESOURCES:**

Donna requested to post four vacant positions:
