# **HUMAN RESOURCES:**

Donna presented the Council with Ordinance 2024-14. This is an amendment to the 2024 Salary Ordinance. This only change is the ending date for dispatch part-time rate of \$30.00 per hour. They will be changing the end date from July 20, 2024, to December 7, 2024. The new director's number one priority is getting more full-time people hired. She

is hoping we will not have to extend this date again. Motion to approve Ordinance 2024-14 was made by Claxton, seconded by Smith, approved 7-0.

Donna is requesting to post one position for the Clerk's Office. This position has been open for around 4 years. It has always been budgeted but not filled. This will be the Small Claims Deputy. This is a COMOT II position and will start out of \$20.60 per hour. Jill Lacy said they are just too short staffed and need to get this position back. Donna advised she still has the part-time position they cannot find anyone for the Election Office position. Titus asked if she would be willing to give up the part-time position and use this person for both offices. Jill said they will try it. Motion to approve the posting of the position was made by Claxton, seconded by Smith, approved 7-0.
