- 2. Highway Clerk Requesting to post a position for a Highway Clerk, this is a full-time position with a pay class of COMOT II. Motion to approve was made by Langkabel, seconded by Barlow, approved 7-0.

## 2025 Salary Ordinance:

Donna presented the Council with Ordinance 2024-24. This is the 2025 Salary Ordinance. This includes a 3% raise for all classifications and a 9.4% raise for the Civilian Pole workers. There is also a change allowing department heads to come to the Council and request to hire someone in up to 10 years instead of just 5 years based on previous experience. Motion to approve was made by Smith, seconded by Langkabel, approved 7-0.
