# **PROSECUTOR/ EMPLOYEE REPLACEMENT:**

Brad is requesting to replace a secretary that is leaving. This secretary has been with the county for over 10 year. Her salary is split between the General and the Adult Protective Services Grant. Motion to approve was made by Sanders, seconded by Compton, approved 7-0

# SHELBYVILLE/SHELBY COUNTY LIBRARY:

Councilman Titus read a letter he received stating that the Library has received a Grant in the amount of \$10,000.00. This was information only; no action was needed.

# COUNTY ASSESSOR/ APPEAL INFORMATION:

Ann wanted to let the Council know that Ryobi Die Cast is appealing their Assessment from 2017 to current. Their assessment is currently at 9 million and they are asking for it to be brought down to 2.9 million. They appealed this once and won, but since then there has been a sale on this building. The Assessor's office also has a signed agreement with this assessment on it thru 2020, but the company is saying the Controller did not have the rights to agree on this assessment. She should know by Friday if will settle on the new figures of 7.5 million, if not this will be going to the State for a hearing. Titus request that Anne let the Council know on Friday if Ryobi agreed to the new assessment. This was information only; no action was required.
