Scott Gabbard is requesting permission to hire the 2 summer time people help and an additional 2 people for the fair. They have figured the cost would be around \$5,400.00, motion to approve was made by Asher, seconded by Langkabel, approved 7-0

# **BRADY CLAXTON / INSURANCE UPDATE:**

Brady Claxton with Pfenninger, Claxton & Estelle Insurance Group presented to the County Council an update of the County's Insurance. Brady advised the county at the current date is down on members that have met their laser for the year. This was information only no action was needed.

#### FSG / HOSPITAL / YMCA POOL:

Greg Guerrettaz with FSG presented a payment schedule to the County Council tonight a payment plan option for the proposed YMCA swimming pool. The hospital is purposing to build a YMCA but has asked the City of Shelbyville and the County to help pay for the warm water swimming pool. The cost to each entity would be \$1,500,000.00. The hospital had proposed 2 payment option plans and then Greg with FSG proposed another payment plan. He advised these are just options if the County Council is willing to help pay for the pool. Motion to approve helping with the finance and approve payment option #3 totaling \$1,575,000.00 pending deciding where the funding will come out of was made by Langkabel, seconded by Asher, approved 7-0

#### **COUNTY CORONER:**

Brad Rund is requesting up to \$11,500.00 to purchase much needed security and storage for the Coroner's files. These files need to be under security surveillance and locked up at all times, incase they are needed for prosecution or law suits. Rund advised he must keep some of his files for 100 years. Currently he is looking at buying 5 filing cabinets and 1 big safe. These are waterproof, fireproof and air tight. Motion to approve the purchases up to \$11,500.00 pending advertisement out of Public Safety Fund was made by Sanders, seconded by Claxton, approved 7-0

### COUNTY ASSESSOR/ BOARD RE-APPOINTMENTS:

Smith suggest that the replacement not start before February 14, 2019. Smith feels two weeks is enough time for training.
