**HUMAN RESOURCE/SALARY ORDINANCE:**

Donna presented the 2020 Salary Ordinance for approval. The Auditor advised at this time that the Ordinance was not presented 10 days before the Council and advised that according to their vote that no Ordinance will not be adopted unless presented to the Council 10 days before the meeting they would not be voted on but was told because this is an Ordinance that is done every year, it was ok that it was not to receive it 10 days before. **PUBLIC SAFETY ACCESS POINT TAX:**
