MISCELLANEOUS:

JUDGE APSLEY / NEW EMPLOYEE MAGISTRATE COURT:

Judge Apsley came before the Council tonight to request for another employee in the Magistrate Court. Apsley explained that with Magistrate having their own court now, there will be more court sessions for her and with the other three courts running at the same time, that leaves her short a Court Reporter if her one employee is on vacation, sick, or just takes the day off. The Council asked if there was a way that another court could share a Court Reporter if this was to happen. Apsley advised that if the other courts are in session, they would not have enough people. Apsley also advised that because the County has a Magistrate Court, the County can now start receiving IV-D money from the state, like the Prosecutor and Clerk do. Apsley advised this money that comes in will go straight to the General Fund, so this will help fund the position. We are looking at possibly receiving anywhere from \$30,000.00 to \$50,000.00. Apsley advised that Debra With Maximus has estimated this, but we need to do a salary study to get concrete numbers. The Council asked for the Judge to try and do the Salary Study and see what it will be like and they will review it in January. Motion to table until January was made by Smith, seconded by Langkabel, approved 7-0

EMERGENCY MANAGEMENT / COVID-19 SUPPLIES REQUESTS:

Ryan Hansome presented the Council with a request from Judge Riggins and Judge Apsley for glass on their benches in their court rooms. Judge Apsley has two quotes from Adams Glass in the amount of \$17,726.00 and Hoosier Glass in the amount of \$7,100.00, motion to approve not to exceed \$7,100.00 was made by Caldwell seconded by Smith, approved 7-0

Riggins received a quote for more plexiglass in the amount of \$835.35, motion to approve was made by Compton, seconded by Smith, approved 7-0

Ryan advised the County received another CARES ACT grant in the amount of \$140,000.00., this is 10% of the original grant the County received, but this money must be spent for educational materials. At this point they are looking at message boards for the mass vaccinations, IPAD and computers for the Health Department, motion to approved was made by Caldwell, seconded by Langkabel, approved 7-0

HUMAN RESOURCE / EMPLOYEE REPLACEMENT:

Highway Dept: Request to replace an employee Truck Driver this is an LTC III position, motion to approve was made by Caldwell, seconded by Compton, approved 7-0

COUNCIL ORDINANCE / MOVE CARES ACT MONEY:

The County Auditor presented the Council with Ordinance 2020-27. This Ordinance gives the directive to move \$1,292,082.80 from the CARES Act to the General Fund for the Reimbursement of the Sheriff's Department Merit Deputy Officers from March 1, 2020 to September 2020. Motion to approve was made by Caldwell, seconded by Compton, approved 7-0

COUNTY ATTORNEY:

Tony Titus wanted to thank Jody Butts for being the County Attorney for the last several years. He advised she is taking interest into a different part of law but will be there to help if needed. Titus was to welcome her replacement Jason Clark. This was information only.
