### **CLERK/ CUM ELECTION FUND:**

Donna requested to be able to advertise to replace a Deputy Prosecutor. This position wasn't going to be available until the end of this year, but the current employee is leaving earlier, and the Prosecutor would like to get the new employee in for some training since this is a specialized position. The Prosecutor would also like to be able to hire this person in at up to 1 year level if the experience is there. Motion to approve was made by Smith, seconded by Langkabel, approved 5-0.

## **2023 BUDGET HEARINGS:**

The County Auditor advised since we are doing the budgets all in one day this year, we need to set a time that the 3<sup>rd</sup> reading will start along with the adoption to put in the advertisement. The DLGF affirmed this is the correct way to do it. It was agreed upon to set the 3<sup>rd</sup> reading and adoption to start at 6:00 p.m.
