### **ADVANTAGE SHELBY COUNTY:**

President Titus presented a Memorandum of Understanding between, the County, City, and Ivy Tech Community College for the Academic School Year of 2023-2024 and 2024-2025. Titus advised Jason Clark has been working with the City and Ivy Tech to make some necessary edits. Jason advised they changed the Community Service to allow any not for profit to be eligible and clarified that the County's contribution is subject to appropriation. Motion to approve was made by Haacker, seconded by Claxton.

## **SUNBEAM BOND:**

President Titus advised Sunbeam has requested to table this for this month, because their attorney is out of the country. Motion to table was made by Claxton, seconded by Haacker, approved 6-0.

# **ECLIPSE / SUNGLASSES PURCHASE:**

President Titus advised he had been approached Blue River Foundation and asked if the County would go in with the City and, Casino to donate \$1,000.00 to purchase eclipse sunglasses for all attendees. Claxton asked Jason if there would be any liability to the County if someone uses these glasses is injured. Jason advised it would depend on the glasses, but he thought if they are going through a reputable company there should not be liability. Titus advised this is a reputable company. Jason advised the first recourse would probably be to the manufacturer. Haacker advised we were not buying the glasses and we are giving the money to Blue River Foundation who will be purchasing the glasses direct from the manufacturer. Jason advised he would look at the purchase agreement. Motion to approve the payment of \$1,000.00 out of Racino was made by Langkabel, seconded by Barlow, approved 6-0.

# **SHERIFF:**
