### **REQUEST TO POST 3 VACANCIES:**

1. Child Support Receptionist: This is a replacement and will be at a COMOT II with a rate of \$21.22 if hired by the end of the year or \$21.85 if hired in 2026 this is a full-time position with 70 hours a week. Motion to approve was made by Ruble, seconded by Barlow, approved 7-0.
2. Sheriff – Custodian: This is a replacement and will be a LTC 4 position with a rate of \$18.44 if hired by the end of the year or \$18.99 if hired in 2026 this is a full-time position with 80 hours a week. Motion to approve was made by Barlow, seconded by O'Connor, approved 7-0.
3. Sheriff – Jail Navigator: This is a new position approved for the 2026 budget. This will be a PAT II position with a rate of \$23.94 - \$27.86 this is a full-time position with 80 hours a week. Motion to approve was made by Mohr, seconded by Barlow, approved 7-0.
