TOM DEBAUN / JIM BROWN GIS EVENT SERVER:

TOM DEBAUN AND JIM BROWN PRESENTED TO THE COUNCIL TONIGHT THE NEED FOR THE FUNDING OF THE GIS EVENT SERVER. THIS LAYER SHOWS ROAD CLOSURES AND DETOURS. WE FEEL THIS IS A VERY IMPORTANT PART OF THE GIS, BUT FEEL THAT THE FUNDING SHOULD COME OUT OF EMERGENCY MANAGEMENT BUDGET. LAST MONTH SCHANTZ PRESENTED IT TO THE COUNCIL FOR FUNDING AND WAS TURNED DOWN, WE ARE REQUESTING FUNDING FOR THIS YEARS BUDGET AND THEN WE WILL MAKE SURE IT GETS PUT IN THE EMERGENCY MANAGEMENT BUDGET FOR 2016. THE BILL WILL BE DUE IN NOVEMBER, AND THE GIS BUDGET WILL BE PAYING FOR THE NEW FLY OVER (PICTURES) FOR THE GIS THIS YEAR AND ISN'T SURE IF HE WILL HAVE ENOUGH TO PAY FOR BOTH IF THE CITY DOESN'T PAY FOR HALF OF THE FLY OVER. THE COUNCIL SUGGEST THAT THEY WAIT UNTIL LATER THIS FALL AND SEE IF JIM WILL HAVE ENOUGH IN HIS BUDGET AND THEN IF NOT THEY WILL DO AN ADDITIONAL APPROPRIATION TO PAY FOR IT.

AMY HAACKER / BLUE RIVER COMMUNITY FOUNDATION:

AMY HAACKER PRESENTED TO THE COUNCIL TONIGHT AN UPDATE ON THE MONEY INVESTED INTO THE COMMUNITY FOUNDATION. THIS WILL BE THE FIRST PAYOUT FOR GRANTS BASED ON THE MONEY INVESTED. THIS WILL BE THE FIRST YEAR FOR GRANT PAYOUTS FROM THE COUNTY AND SHE IS VERY EXCITED. SOME OF THE COUNCIL ASKED HOW THEY DETERMINE WHO GETS THE MONEY, HAACKER ADVISED THIS MONEY ONLY GOES TO A 501 (C) 3 ORGANIZATION. THE DEPUTY AUDITOR ADVISED THE PAYMENT TO BLUE RIVER COMMUNITY FOUNDATION GOING OUT THIS WEEK WILL BE \$184,498.19 BASED ON LAST YEARS REVENUES. THIS WAS INFORMATION ONLY

LOIT / PUBLIC SAFETY TAX:

DEPUTY AUDITOR GLACKMAN PRESENTED THE COMMISSIONERS WITH A POWER POINT IN REGARDS TO THE NEW LEGISLATION THAT HAS COME OUT ON THE LOIT TAX. HB1475 HAS BEEN APPROVED BY BOTH THE SENATE AND THE HOUSE AND IS GOING TO THE GOVERNORS DESK FOR SIGNATURE. THIS BILL WILL ALLOW A COUNTY TO NOW ONLY ADOPT THE LOIT PUBLIC SAFETY TAX WITHOUT ADOPTING THE OTHER TWO LOIT TAXES. THIS WOULD BE A GREAT OPPORTUNITY FOR THE COUNTY TO BE

ABLE TO BRING PUBLIC SAFETY MONEY IN AND THIS WOULD ALLOW THE SHERIFF'S OFFICE TO HIRE MORE DEPUTIES AND JAIL OFFICERS. ACCORDING TO THE JAIL AUDIT REPORT THE JAIL IS CURRENTLY 13 JAIL OFFICERS SHORT THE THEY ARE SUPPOSED TO BE. THE PUBLIC SAFETY RATE WOULD BE THE SAME RATE THAT WE ARE USING FOR THE CEDIT. IN A YEAR WE COULD POSSIBLY BRING IN \$947,427.00 PER YEAR AND THE CITY COULD BRING IN \$1,248,093.00 PER YEAR, THIS MONEY WOULD BE A HUGE IMPACT ON THE SHERIFF'S DEPARTMENT. THIS WAS INFORMATION ONLY

THE AUDITOR DID ASK IF SHE COULD HAVE PERMISSION TO CONTACT UMBAUGH FOR PRICING TO HELP WITH FIGURES IF WE WERE TO DO THIS ALONG WITH THE NUMBERS FOR THE EXCESS LEVY. THE COUNCIL OK'D THIS.
