UNSAFE BUILDINGS:

ROBERT LEWIS PRESENTED TO THE COUNCIL THE NEED FOR MORE MONEY TO CONTINUE THE RAISING OF UNSAFE BUILDINGS IN THE COUNTY. WE STARTED THIS PROGRAM ABOUT 9 YEARS AGO AND IN 2009 WE ASKED FOR \$40,000.00 OUT OF RACINO AND ANOTHER \$50,000.00 ANOTHER YEAR SO WITH \$90,000.00 WE HAVE RAISED 17 HOMES AVERAGE RAISE IS AROUND \$5,600.00. WE HAD A COMPANY THAT WAS DOING THEM CHEAPER, BUT THE OWNER PASSED AWAY AND THE NEW QUOTES HAVE GONE UP. WE HAVE HAD 10 OWNERS RAISE THE HOMES THEMSELVES. CURRENTLY WE HAVE HOMES IN MORRISTOWN, FREEPORT, FLAT ROCK, AND FAIRLAND. WE HAVE TRIED TO GET THESE HOMEOWNERS TO GO THROUGH THE BLIGHT PROGRAM, BUT THEY WON'T WORK WITH US. IN THE BLIGHT PROGRAM IF YOU HAVE A BASEMENT THEY WILL PAY YOU \$10,000.00 AND NO BASEMENT THEY WILL PAY \$6,000.00. THE DEPUTY AUDITOR TOLD THE COUNCIL THAT THEY HAVE RECEIVED \$17,000.00 IN FEES ASSESSED AND WONDERED IF THE COUNCIL COULD APPROVE ANY MONEY THAT IS REPAID FROM THE RAISING. IF THEY COULD JUST GO AHEAD AND PUT THE MONIES BACK IN THE APPROPRIATION LINE. MOTION TO APPROVE ANY RETURNED MONIES TO GO BACK INTO THE APPROPRIATION LINE AND TO APPROVE USING ANOTHER \$40,000.00 FROM RACINO WAS MADE BY SANDERS, SECONDED BY LANGKABEL, APPROVED 6-0

BRADY CLAXTON / HEALTH INSURANCE:

BRADY CLAXTON PRESENTED TO THE COUNCIL TONIGHT AN UPDATE ON HEALTH INSURANCE AND THE FACT IT IT'S NOT LOOKING GOOD FOR THE COUNTY. HE ADVISED IN 2015 THEY WERE ABLE TO SIGN WITH SIHO AND WITH NOT LASERS. NOW THE RISK IS MUCH HIGHER HE KNOWS THAT THERE WILL BE PEOPLE WITH LASERS NEXT YEAR. WE CURRENTLY HAVE 21 PEOPLE WITH CASE MANAGEMENT RIGHT NOW, WHICH MEANS THEY HAVE NURSES WORKING WITH THE PATIENT, POSSIBLY EVEN GOING TO APPOINTMENTS WITH THEM. DONNA AND BRADY WILL BE STARTING NEGOTIATING WITH THE INSURANCE COMPANIES PROBABLY IN JUNE OR

JULY SO HOPEFULLY WE CAN LOOK AT BETTER OPTIONS. THIS WAS INFORMATION ONLY. NO ACTION WAS TAKEN AT THIS TIME.

HEATHER ROSS WITH MHP CAME IN TONIGHT TO GIVE THE COUNCIL AN UPDATE ON THE CLINIC.
