#### **HIGHWAY UPDATE:**

COMMISSIONER ROSS GAVE A BRIEF UPDATE OF WHERE THEY ARE ON THE BRIDGES, CULVERTS & PAVING. THEY TALKED ABOUT SOME OF THE EXTRA MONEY THAT SHOULD START COMING IN. THEY ALSO SAID THEY HAVE STARTED ON THE GRANT APPLICATION AND HAVE UNTIL JULY 15, 2017 TO FINISH. ASHER ASKED HOW MANY MILES THEY HAVE DONE ALREADY AND WHAT THE COST IS PER MILE. ANDERSON ADVISED THEY HAVE DONE 23 MILES AND THE COST IS \$45,000.00 - \$50,000.00 PER MILE. WHAT WOULD THE COST BE IF OUT SOURCED; ANDERSON ADVISED IT WOULD BE DOUBLE. FISCHER ASKED IF ANYONE IN THE MEETINGS OR CONFERENCES YOU HAVE GONE TO, HAS MENTIONED THAT THINGS WERE GOING TO GET EASIER TO TAKE CARE OF THINGS WITH THE NEW BILL, FISCHER SEEMS TO THINK THAT THE CONTRACTORS AREN'T GOING TO BE ABLE TO KEEP UP WITH THE DEMAND ARE COST GOING TO GO UP. THIS PARTICULAR PERSON THAT WE ARE TALKING ABOUT HAS EXPERIENCE AND HAS BEEN IN THE MARION COUNTY PROSECUTORS OFFICE FOR A WHILE. I HAVE HER NOTHING BUT GOOD, ABOUT HIS CASES.
