### ORDINANCE NO. 2025 - 61

# ORDINANCE APPROVING REQUEST OF SHELBY COUNTY RECORDER TO PAY EXPENSES OF THE SHELBY COUNTY RECORDER'S OFFICE FOR THE 2025 CALENDAR YEAR FROM THE SHELBY COUNTY RECORDER'S RECORDS PERPETUATION FUND

WHEREAS, on January (2) [5], 2025, Jessica Pile, in her capacity as Shelby County Recorder, presented her Affidavit of Recorder of Shelby County, Indiana, to the Shelby County Council for review and approval;

WHEREAS, said Affidavit was submitted to the Shelby County Council pursuant to Indiana Code section 36-2-7-10.2(b), which specifically sets forth the statutory requirements for an Indiana county recorder to request approval to pay all or a portion of the expenses of the county recorder's office for the following calendar year from the county recorder's records perpetuation fund;

WHEREAS, said Affidavit specifically requested the Shelby County Council to approve the payment of expenses of the Shelby County Recorder's Office for the 2025 calendar year from the Shelby County Recorder's Records Perpetuation Fund in an amount not to exceed Two Hundred Eighty Thousand Four Hundred and Eighty Dollars and Zero Cents (\$284,042.00); and

WHEREAS, the Shelby County Council found that said Affidavit complies with the statutory requirements of Indiana Code section 36-2-7-10.2(b) and desires to grant the Shelby County Recorder's request pursuant to Indiana Code section 36-2-7-10.2(c).

## NOW THEREFORE, it is ordained by the Shelby County Council as follows:

- 1. The Shelby County Council approves the request of Jessica Pile, in her capacity as Shelby County Recorder, to pay the expenses of the Shelby County Recorder's Office for the 2025 calendar year from the Shelby County Recorder's Records Perpetuation Fund in an amount not to exceed Two Hundred Eighty Thousand Four Hundred and Eighty Dollars and Zero Cents (\$284,042.00).
  - 2. This Ordinance shall be effective upon its passage.

- 7. I request that up to \$284,042.00 of the Fund may be used to supplement payment of the expenses of the Recorder's Office for the 2025 calendar year.
- 8. I am making this affidavit to induce the Shelby County Council to adopt an ordinance under I.C. 36-2-7-10.2(b)(2) and I.C. 36-2-7-10.2 (c) approving my request.
- 9. I affirm, under the penalties for perjury, that the forgoing representations are true and accurate to the best of my knowledge.
