Ordinance No. 2025- 02

An Ordinance to amend the Shelby County Records to vacate alleys located between the north part of lots 4 and 5 to the intersection of 800 N and 850 W (platted as Center St); the alley between lots 6 and 7 and the NE part of lots 10 and 11 on the north side of 850 W (platted as Vine St.); the right away land adjacent to lot 8, east of 850 W (platted as Greenwood St); all the right away land platted as Orchard Street, north of 800 N and east of 850 W.; All public right aways lying north of north right away line of 800 N and east of the east right away line of 850 W. in the town of Brookfield, at the property address of 8438 W 800 N, Fairland, IN 46126.

BE IT ORDAINED by the board of Commissioners of Shelby County, Indiana as follows:

<u>Section 1: Purpose.</u> The purpose of this Ordinance shall be to vacate a dedicated public way being an alley.

<u>Section 2: Notice.</u> Notice pursuant to IC 36-7-3-12, by certified mail to each owner of land that abuts the alley proposed to be vacated was given according to IC 5-3-1. Legal notice was published, and a public hearing was held on February 10, 2025, at 8:00am, according to law, before the Shelby County Commissioners.

Section 3: Vacation of Alley. The Alleys (located between the northerly part of lots 4 and 5 and between lots 6 and 7 and the NE parts 10 and 11, to the northerly line of the railroad in the town of Brookfield) located at the property address of 8438 W 800 N, Fairland, IN 46126, being vacated by this Ordinance is that part thereof commencing at the property.

<u>Section 4: Effective Date:</u> This Ordinance shall be in full force and effect from and after its adoption by the Board of Commissioners of Shelby County, Indiana.

<u>Section 5: Repealable Provisions:</u> All ordinances and parts thereof in conflict with the specific amendments or provisions herein provided and hereby repealed.

Adopted this 1014 day of February, 2025 by vote of 3 ayes and 5 nays of the members of the Board of Commissioners of Shelby County, Indiana.
