#### ORDINANCE NO. 2020 - 03

# ORDINANCE INCREASING THE SHELBY COUNTY ASSESSOR'S USER FEE FOR SALES DISCLOSURE FORMS

WHEREAS, the Shelby County Council ("Council") is responsible for the fiscal decisions of Shelby County, Indiana;

WHEREAS, pursuant to the Indiana Home Rule Statute in Indiana Code section 36-1-3, the Council is empowered to exercise such powers that are not specifically denied it, which may be necessary for efficient operation of county government;

WHEREAS, pursuant to Indiana Code section 36-1-3-8, the Council has the power to impose a service charge or user fee provided that it is reasonably related to reasonable and just rates and charges for services;

WHEREAS, the Shelby County Assessor desires to increase its user fee for submission of sales disclosure forms from \$5.00 per sales disclosure form to \$25.00 per sales disclosure form;

WHEREAS, an increase in the Shelby County Assessor's user fee is necessary to pay for expenses related to software required for submission of sales disclosure forms by the Shelby County Assessor beginning in 2020, and is reasonably related to reasonable and just rates an charges for services incurred by the Shelby County Assessor;

WHEREAS, the Council found that the Shelby County Assessor's request complies with the statutory requirements of Indiana Code section 36-1-3-8 and desires to grant the Shelby County Assessor's request to increase its user fee for review and submission of sales disclosure forms.

### NOW, THEREFORE, it is ordained by the Council as follows:

- 1. The Council approves the request of the Shelby County Assessor to increase its user fee for submission of sales disclosure forms. A user fee for the Shelby County Assessor's submission of sales disclosure forms in the amount of \$25.00 per sales disclosure form shall be charged by the Shelby County Assessor's Office as allowed by Indiana Code section 36-1-3-8.
- 2. All ordinances, resolutions, and orders or parts thereof in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.
- 3. This Ordinance shall become effective April 1, 2020 as approved by the Council.
